

1. IDENTIFICATION OF THE SUBSTANCE / PREPARATION AND OF THE COMPANY / UNDERTAKING

2. COMPOSITION / INFORMATION ON INGREDIENTS



• A mixture of Solvent Refined Mineral Oil, Chlorinated Paraffin, Sulphurised Ester and Lubricity Additives.

3. HAZARDS IDENTIFICATION

Main hazards, Overexposure Effects:

Skin Contact: Will defat the skin and may cause irritation and redness after prolonged or repeated contact.

Eye Contact: Irritation.

Ingestion: There may be soreness and redness of the mouth and throat. Nausea and stomach pain may occur. There may be vomiting.

Inhalation: Excessive quantities may cause headaches and drowsiness. Continued exposure will have a narcotic effect leading eventually to unconciousness.

4. FIRST AID MEASURES (SYMPTOMS)

Skin contact:

There may be irritation and redness at the site of contact.

Eye contact:

There may be irritation and redness. The eyes may water profusely.

Ingestion:

There may be soreness and redness of the mouth and throat. Nausea and stomach pain may occur. There may be vomiting.

Inhalation:

There may be irritation of the throat with a feeling of tightness in the chest.

4. FIRST AID MEASURES (ACTION)

Skin contact:

Remove all contaminated clothes and footwear immediately unless stuck to skin. Drench the affected skin with running water for 10 minutes or longer if substance is still on skin. Consult a doctor.

Eye contact:

Bathe the eye with running water for 15 minutes. Consult a doctor.

Ingestion: Wash out mouth with water. Do not induce vomiting. If conscious, give half a litre of water to drink immediately. Consult a doctor.

Inhalation:

Remove casualty from exposure ensuring one's own safety whilst doing so. Consult a doctor.

5. FIRE-FIGHTING MEASURES

Extinguishing media:

Alcohol or polymer foam. Carbon dioxide. Dry chemical powder. Use water spray to cool containers.

Exposure hazards:

Highly flammable. In combustion emits toxic fumes. Forms explosive air-vapour mixture. Vapour may travel considerable distance to source of ignition and flash back.

Protection of fire-fighters:

Wear self-contained breathing apparatus. Wear protective clothing to prevent contact with skin and eyes.

6. ACCIDENTAL RELEASE MEASURES

Personal precautions:

Refer to section 8 of SDS for personal protection details. If outside do not approach from downwind. If outside keep bystanders upwind and away from danger point. Mark out the contaminated area with signs and prevent access to unauthorised personnel. Turn leaking containers leak-side up to prevent the escape of liquid. Eliminate all sources of ignition.

Environmental precautions: Do not discharge into drains or rivers. Contain the spillage using bunding.

Clean-up procedures: Absorb into dry earth or sand. Transfer to a closable, labelled salvage container for disposal by an appropriate method. Do not use equipment in clean-up procedure which may produce sparks.

7. HANDLING AND STORAGE

Handling requirements: Avoid direct contact with the substance. Ensure there is sufficient ventilation of the area. Do not handle in a confined space. Avoid the formation or spread of mists in the air. Smoking is forbidden. Use non-sparking tools.

Storage conditions: Store in cool, well ventilated area. Keep container tightly closed. Keep away from sources of ignition. Prevent the build up of electrostatic charge in the immediate area. Ensure lighting and electrical equipment are not a source of ignition.

8. EXPOSURE CONTROLS / PERSONAL PROTECTION Hazardous ingredients:

• PROPANE WEL (8 hr exposure limit): 1800 mg/m3 WEL (15 min exposure limit): 7200 mg/m3

• BUTANE WEL (8 hr exposure limit): 1450 mg/m3 WEL (15 min exposure limit): 1810 mg/m3

Engineering measures: Ensure there is sufficient ventilation of the area. Ensure lighting and electrical equipment are not a source of ignition.

Respiratory protection: Self-contained breathing apparatus must be available in case of emergency.

Hand protection: Impermeable gloves.

Eye protection: Safety glasses. Ensure eye bath is to hand.

Skin protection: Impermeable protective clothing.

Hazard symbols:

Risk phrases:
